REQUIREMENTS FOR THE ABSTRACTS

- Text in Microsoft Word 6.0, (7.0) Windows, *.rtf;
- volume of the abstracts: 4-5 pages in the A4 format (297x210 mm), portrait mode;
- orientation fields: left – 25 mm, right – 10, top, bottom – 20 mm;
- text – Times New Roman, kg – 14, line spacing – 1,5, style – Normal;
- on the first page on the right corner must be included: name and surname, the title of the abstracts in bold indicate in the middle, then text. .

At the end: author's name and surname, information about author: position, scientific degree, title, name of institution;

- list of references;
- references in the text must be in in square brackets, use continuous numbering, not alphabet;
- pages mustn't be numbered.
